If the Furlough-based Salary Program ends early, those employees who have NOAs and NORs will be issued new NOAs and NORs. These will reflect the annual salary or hourly rate previous to implementation of the Furlough-based Salary Program, unless other authorized agreements or offer letters are scheduled to take effect before the earlier end date for the programs.

Please note that NOAs and NORs for fiscal employees will not be issued for the short-term period of July 1, 2020, through Aug 9, 2020. The terms of service for their contract and pay rate as of June 30, 2020, will continue for this period unless other authorized agreements or offer letters are scheduled to take effect before Aug 9, 2020.
